


At APS we construct portfolios based on our clients' goals, risk appetite, personal and tax circumstances. Our portfolio managers offer both discretionary and advisory investment services.

APS Pathfinder Fund Presenting an exciting investment opportunity in environmentally sustainable agriculture – a managed fund that combines various high-yielding products such as Asian hardwood plantations (Ebony, Walnut, Teak, and Rosewood) and recyclable bio plantations. These ventures produce plant-based enzymes for animal feed and bioethanol and focus on creating naturally occurring biopolymers. Furthermore, the fund converts agricultural biomass into a carbon-rich liquid, which is then pumped underground to significantly reduce carbon from the atmosphere. Additionally, the funds biomass recycling initiative transforms organic waste into renewable energy, making a substantial contribution to environmental sustainability.



The Pathfinder offers high yield returns through environmentally responsible initiatives. It provides a fixed return of 16.7% per annum with quarterly distribution payments over a 12-month term. The Pathfinder account is popular among our clientele and serves as a starting point for establishing both a strong relationship and financial success. It is the stepping stone to financial freedom.

APS Timber Fund Our vision at APS is to establish the benchmark for excellence in the global timber investment industry. We aim to achieve this by pioneering strategies that combine significant financial returns with unwavering environmental responsibility. Our goal is to lead sustainable forestry practices and illustrate that economic success can indeed coexist with ecological stewardship.

Our mission at APS is to provide investors with exceptional opportunities for financial growth through sustainable timber investments that also support environmental preservation. We strive to integrate practices that enhance biodiversity, reduce carbon footprints, and ensure longevity. By harnessing the potential of renewable timber markets globally, we aim to deliver robust returns while upholding the highest standards of ethics and sustainability. We are committed to expanding our asset base by acquiring high-value timberlands in Asia, with a particular focus on Asian hardwoods such as Walnut, Teak, Agarwood, Rosewood, rubberwood, and Acacia. These trees meet the demand for furniture, construction, marine, and aviation timber. This investment opportunity is for a 5-year term, offering investors a 21% annual return with quarterly distribution payments. There is also an option for renewal at the end of 5 years.

APS Agriculture Fund Investing in APS Agriculture Fund offers an opportunity to invest in biomass recycling facilities in North America and Asia that provide high returns.

These facilities use innovative waste management and energy production methods to promote renewable energy adoption, contribute to waste reduction, and support global efforts towards carbon neutrality. The APS Agriculture Fund focuses on investing in biomass recycling projects that use advanced technology to convert agricultural, forestry, and municipal waste into energy.

These projects not only help reduce greenhouse gas emissions but also generate economic returns through the sale of bioenergy and byproducts. In addition to biomass recycling projects, APS also invests in facilities that produce plant-based proteins and enzyme manufacturing, developing a range of naturally occurring biopolymers, and converting agricultural biomass into a carbon-rich liquid. The investment has a 7-year term with annual returns of 23% and quarterly distribution payments. There is an option to renew the investment at the end of the 7 years.


